

**MINUTES OF THE MEETING OF MEGHALAYA STATE PLANNING
BOARD HELD ON THE 19.11.2018 AT 12:00 P.M. IN THE OFFICE

SHILLONG**

Agenda :- 1. Discussion on requirement of land for Construction of road from Lum Shillong Road towards Shillong View point under RIDF.

The meeting was chaired by Shri Lambor Malngiang, MLA, Chairman, of the Meghalaya State Planning Board. The Chairman welcome all the members and mentioned that the main intention of the meeting is to expedite the construction of road under RIDF, steps already taken by PWD, Forest and Soil Conservation Dept and Dorbar Hima Myllem for the requirements of land for Public Interest.

The followings were the decision emerges after a series of deliberations and discussion.

1. The Director of Soil Conservation confirm that the Road projects will not affect the afforestation project since the road project is aligned to the left side from the present main road. The Shillong Division has verified that the afforestation land falls outside the purview of proposed road.
2. During the discussion Paiem of Hima Myllem, Myntri Kharlukhi and Myntri Sohtun of Dorbar Hima Myllem also confirm that the land for the proposed road project land belongs to the Hima Myllem and handing over the same for the road project will be done only after pending issues with the Raid Laban Community are settle amicably.
3. The Chairman emphasise that with the construction of the proposed road the inflow of tourists visiting the area will increase. This will benefit the locals residing in the area and will boost their economic livelihood.
4. Official from Forest Department also confirm that the Forest land required for the road project has been identified and surveyed.
5. PWD officials mentioned that approximate requirement of land from Hima Myllem is around 70,000 sqft i.e road length of 600 metres by 10 metre width.

The meeting ended with a vote of thanks from the Chair.






